Payment Plans:
Plan A: One payment due May 15, 2025
Plan B: Two payments due May 15, 2025 and November 15, 2025
Plan C: Twelve payments due May 15, 2025 through April 15, 2026

Payment Plan Discount or Service Charge:

A \$100 discount is given with Plan A and a \$50 discount is given with Plan B. It is applied to the payment due May 15, 2025.

Late Fee: Statements are mailed after the 1st of the month. Payments are due on the 15th of the month. A late fee of 1.5% will be added to the unpaid balance after the 25th of the month.
